That Regulation does not lay down a list of socially sustainable economic activities. Sustainable investments with an environmental objective might be aligned with the Taxonomy or not.

To what extent were the environmental and/or social characteristics promoted by this financial product met?

The Fund's promotion of environmental and/or social characteristics included:

During 2025, the Fund's sustainable investments were made in companies whose economic activities were assessed to contribute to an environmental or social objective in accordance with the United Nations Sustainable Development Goals (SDGs) through the companies' products, services and/or technologies, and/or the EU Taxonomy, and/or a company's green revenues, while ensuring that they did not cause significant harm to any other environmental or social objective and that they followed good governance practices.

The proportion of sustainable investments in SPP Generation 60-tal amounted to an average of 22.06 percent during 2025, based on quarterly measurements.

The Fund's environmentally sustainable investments contributed to the objectives of climate change mitigation and climate change adaptation in accordance with the EU Taxonomy for environmentally sustainable activities.

The Fund promoted environmental and/or social characteristics through its exclusion criteria for companies with operations related to controversial weapons, nuclear weapons, weapons and military equipment, fossil fuels, alcohol, tobacco, cannabis, pornography and commercial gambling activities. The Fund also excluded companies confirmed to be acting in violation of international norms and conventions related to the environment, human rights, labour rights, or the prevention of corruption and bribery. Furthermore, the Fund promoted environmental and/or social characteristics by considering principal adverse impacts on

sustainability factors (PAI indicators) related to the environment, climate, human rights, labour rights, and the prevention of corruption and bribery.

The benchmark index used by the Fund has not been designated for the purpose of attaining the environmental or social characteristics promoted by the Fund.

• **What were the objectives of the sustainable investments that the financial product partially made and how did the sustainable investment contribute to such objectives?**

Skandiabanken Covered Bond

The proceeds are linked to secured residential mortgage loans for energy-efficient properties. The framework is designed to direct capital towards low-carbon housing and promote long-term sustainability within the residential sector.

Jernhusen

The bond finances green and energy-efficient properties in railway and station environments. The framework encompasses energy efficiency measures, renewable energy and sustainable building materials. The projects contribute to climate-smart public transportation and sustainable urban development.

• How did the sustainable investments that the financial product partially made not cause significant harm to any environmental or social sustainable investment objective?

For all investments in the Fund, a review is conducted both at the time of investment and on an ongoing basis against the management company's exclusion criteria to ensure that the sustainable investments do not cause significant harm to any environmental or social objective.

The EU Taxonomy sets out a "do not significant harm" principle by which Taxonomy-aligned investments should not significantly harm EU Taxonomy objectives and is accompanied by specific EU criteria.

The "do not significant harm" principle applies only to those investments underlying the financial product that take into account the EU criteria for environmentally sustainable economic activities. The investments underlying the remaining portion of this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

Any other sustainable investments must also not significantly harm any environmental or social objectives.



How did this financial product consider principal adverse impacts on sustainability factors?

The Fund considers principal adverse impacts on sustainability factors (PAIs). This is done through the management company's DNSH (Do No Significant Harm) assessment, whereby potential adverse impacts are identified and analysed. Certain adverse impacts are addressed by excluding investments associated with fossil fuels (PAI 1.4), controversial weapons (PAI 1.14), and companies that are found to be in breach of international norms and conventions, including matters relating to human rights (PAI 1.10). Other adverse impacts on sustainability factors are managed through active ownership and engagement with investee companies.

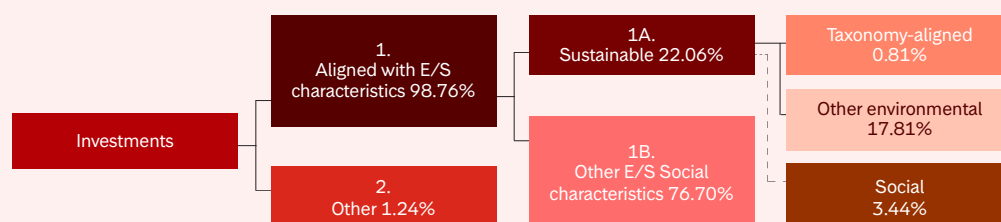

To what extent were the sustainable investments with an environmental objective aligned with the EU Taxonomy?

The bar charts below illustrate the investments' alignment with the environmental objectives of the EU Taxonomy.

Where possible, companies have begun reporting the extent to which their activities are aligned with the EU Taxonomy. In other cases, estimated data is used, which the management company considers sufficient to determine whether a company contributes to one or more of the EU's environmental objectives and can therefore be considered a sustainable investment.

To calculate the proportion of taxonomy-aligned investments, reported data from a third-party data provider is used. The availability of such data remains limited. The management company's taxonomy reporting includes only the taxonomy alignment that has been reported by the companies themselves.

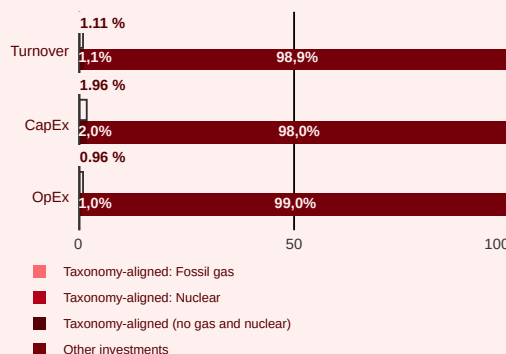

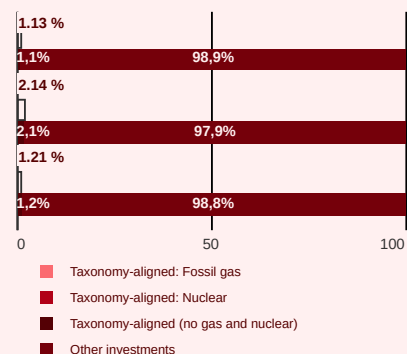

The graphs below show in green the percentage of investments that were aligned with the EU Taxonomy. • What was the share of investments made in transitional and enabling activities?

The Fund's share of taxonomy-aligned investments during 2025 amounted to 0.03 percent in transitional activities and 0.55 percent in enabling activities.

To comply with the EU Taxonomy, the criteria for **fossil gas** include limitations on emissions and switching to fully renewable power or low-carbon fuels by the end of 2035.

For **nuclear energy**, the criteria include comprehensive safety and waste management rules

Enabling activities directly enable other activities to make a substantial contribution to an environmental objective.

Transitional activities are activities for which low-carbon alternatives are not yet available and among other have greenhouse gas emission levels corresponding to the best performance.

Taxonomy-aligned activities are expressed as a share of:

– **turnover**, reflects the "greenness" of investee companies today.

– **capital expenditure (CapEx)**, shows the green investments made by investee companies, relevant for a transition to a green economy.

– **operational expenditure (OpEx)**, reflects the green

For 2022, the fund reported no taxonomy-aligned investments, as companies had generally not yet begun reporting the extent to which their activities were aligned with the EU Taxonomy.



What was the share of socially sustainable investments?

The Fund's share of sustainable investments contributing to a social objective was 3.44 percent during 2025.



What investments were included under "other", what was their purpose and were there any minimum environmental or social safeguards?

The Fund's "other" allocation amounted to 1.24 percent and consists of cash and cash equivalents. There are no environmental or social minimum safeguards applicable to this portion.



What actions have been taken to meet the environmental and/or social characteristics during the reference period?

SPP Generation 60-tal was managed during 2025 in accordance with its sustainability criteria, and companies that do not meet these requirements are excluded from the fund's investment universe. As of year-end 2025, 516 of the 2,496 companies included in the underlying indices were excluded.

Our active ownership activities include, among other things, voting at general meetings and maintaining ongoing dialogues with portfolio companies. These engagements are conducted either directly or in collaboration with other investors. The purpose is to strengthen corporate governance, reduce sustainability-related risks in the companies in which the fund invests, and mitigate potential adverse impacts on sustainability factors. This, in turn, supports positive long-term value creation.

During 2025, the fund maintained 355 ongoing engagements involving 237 companies. Of these, 39% related to environmental issues, 46% to social issues and 14% to corporate governance matters. Of the engagements, 61 were conducted directly between us and the companies, while 337 were carried out in collaboration with other investors. In these collaborations, Storebrand may assume either a leading or a supporting role. In a leading role, we are responsible for the engagement and direct interaction with the company. In a supporting role, we contribute our capital while another investor leads the dialogue.

Of the 237 engagements during the year, a significant proportion focused on specific ESG-related issues, including:

- 40.5% on climate change
- 32.6% on biodiversity
- 24.4% on human rights

Furthermore, a number of engagements can be linked to the United Nations Sustainable Development Goals (SDGs), including:

- 33.6% to SDG 15 – Life on Land
- 33.1% to SDG 13 – Climate Action
- 31.6% to SDG 16 – Peace, Justice and Strong Institutions
- 31.1% to SDG 8 – Decent Work and Economic Growth
- 29.9% to SDG 10 – Reduced Inequalities

As individual engagements may contribute to multiple goals, the aggregate percentages exceed 100%.

Several engagements can also be linked to Principal Adverse Impact (PAI) indicators, including:

- 130 engagements concerning breaches of the principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises;
- 127 engagements concerning inadequate processes and mechanisms for monitoring compliance with these principles;

- 60 engagements concerning greenhouse gas emissions;
- 44 engagements concerning deforestation; and
- 15 engagements concerning carbon emissions.

During the reporting period, the management company exercised voting rights on behalf of the fund at shareholder meetings where the ownership stake was considered material, in matters deemed to be in the best interests of unitholders, and in cases where proposals were assessed to be inconsistent with the management company's stewardship policy. In 2025, voting rights were exercised at 649 general meetings, representing 92.23% of the fund's assets under management.
