To what extent were the environmental and/or social characteristics promoted by this financial product met?

The Fund's promotion of environmental and/or social characteristics included:

During 2025, the Fund's sustainable investments were made in companies whose economic activities were assessed to contribute to an environmental or social objective in accordance with the United Nations Sustainable Development Goals (SDGs) through the companies' products, services and/or technologies, and/or the EU Taxonomy, and/or a company's green revenues, while ensuring that they did not cause significant harm to any other environmental or social objective and that they followed good governance practices.

The proportion of sustainable investments in Storebrand Europa amounted to an average of 33.14 percent during 2025, based on quarterly measurements.

The Fund's environmentally sustainable investments contributed to the objectives of climate change mitigation and climate change adaptation in accordance with the EU Taxonomy for environmentally sustainable activities.

The Fund promoted environmental and/or social characteristics through its exclusion criteria for companies with operations related to controversial weapons, nuclear weapons, weapons and military equipment, fossil fuels, alcohol, tobacco, cannabis, pornography and commercial gambling activities. The Fund also excluded companies confirmed to be acting in violation of international norms and conventions related to the environment, human rights, labour rights, or the prevention of corruption and bribery. Furthermore, the Fund promoted environmental and/or social characteristics by considering principal adverse impacts on

sustainability factors (PAI indicators) related to the environment, climate, human rights, labour rights, and the prevention of corruption and bribery.

The benchmark index used by the Fund has not been designated for the purpose of attaining the environmental or social characteristics promoted by the Fund.

• **How did the sustainable investments that the financial product partially made not cause significant harm to any environmental or social sustainable investment objective?**

For all investments in the Fund, a review is conducted both at the time of investment and on an ongoing basis against the management company's exclusion criteria to ensure that the sustainable investments do not cause significant harm to any environmental or social objective.

The Fund has complied with its exclusion criteria relating to controversial sectors and products and services that may be considered to hinder sustainable development, including companies involved in activities that cause significant harm to the environment or climate, controversial weapons, tobacco and cannabis, alcohol, pornography, gambling activities, weapons, fossil fuels (coal, oil and gas), as well as large fossil fuel reserves, oil sands, and unsustainable palm oil production.

– **Were sustainable investments aligned with the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles on Business and Human Rights?**

The sustainable investments were aligned with the OECD Guidelines for Multinational Enterprises and the UN Guiding Principles on Business and Human Rights. Compliance was ensured through the management company's internal analyses, the application of its exclusion policy, and ESG data obtained from external data providers.

Principal adverse impacts are the most significant negative impacts of investment decisions on sustainability factors relating to environmental, social and employee matters, respect for human rights, anti-corruption and anti-bribery matters.

The EU Taxonomy sets out a “do not significant harm” principle by which Taxonomy-aligned investments should not significantly harm EU Taxonomy objectives and is accompanied by specific EU criteria.

The “do not significant harm” principle applies only to those investments underlying the financial product that take into account the EU criteria for environmentally sustainable economic activities. The investments underlying the remaining portion of this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

Any other sustainable investments must also not significantly harm any environmental or social objectives.



How did this financial product consider principal adverse impacts on sustainability factors?

The Fund considers principal adverse impacts on sustainability factors (PAIs). This is done through the management company's DNSH (Do No Significant Harm) assessment, whereby potential adverse impacts are identified and analysed. Certain adverse impacts are addressed by excluding investments associated with fossil fuels (PAI 1.4), controversial weapons (PAI 1.14), and companies that are found to be in breach of international norms and conventions, including matters relating to human rights (PAI 1.10). Other adverse impacts on sustainability factors are managed through active ownership and engagement with investee companies.

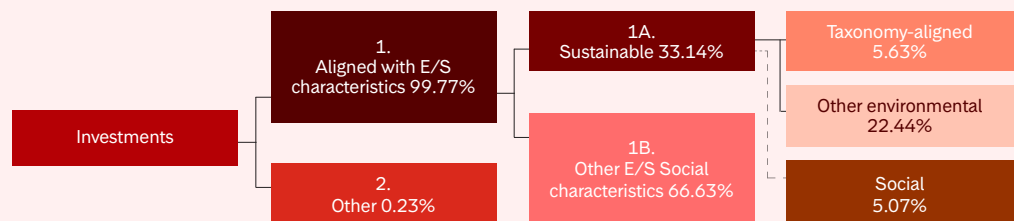

To comply with the EU Taxonomy, the criteria for **fossil gas** include limitations on emissions and switching to fully renewable power or low-carbon fuels by the end of 2035. For **nuclear energy**, the criteria include comprehensive safety and waste management rules

Enabling activities directly enable other activities to make a substantial contribution to an environmental objective.

Transitional activities are activities for which low-carbon alternatives are not yet available and among other have greenhouse gas emission levels corresponding to the best performance.

Taxonomy-aligned activities are expressed as a share of:
– **turnover**, reflects the “greenness” of investee companies today.

– **capital expenditure (CapEx)**, shows the green investments made by investee companies, relevant for a transition to a green economy.

– **operational expenditure (OpEx)**, reflects the green operational activities of investee companies.



To what extent were the sustainable investments with an environmental objective aligned with the EU Taxonomy?

The bar charts below illustrate the investments’ alignment with the environmental objectives of the EU Taxonomy.

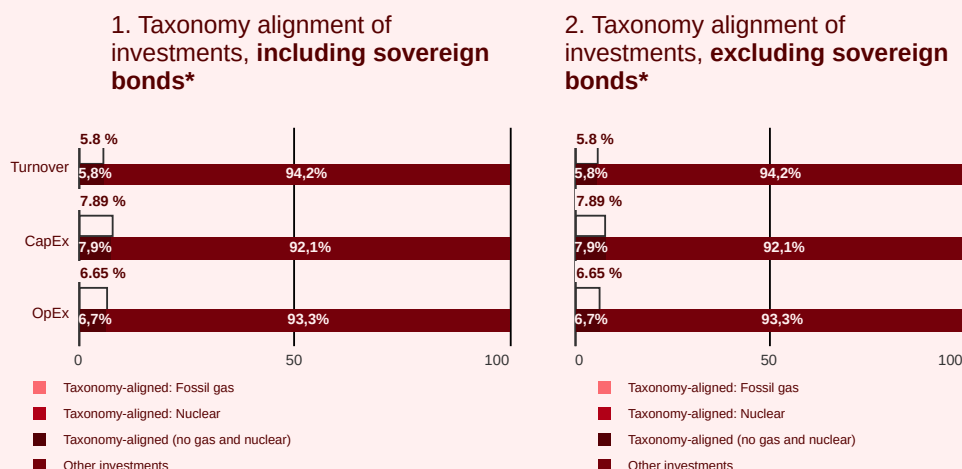
Where possible, companies have begun reporting the extent to which their activities are aligned with the EU Taxonomy. In other cases, estimated data is used, which the management company considers sufficient to determine whether a company contributes to one or more of the EU’s environmental objectives and can therefore be considered a sustainable investment.

To calculate the proportion of taxonomy-aligned investments, reported data from a third-party data provider is used. The availability of such data remains limited. The management company’s taxonomy reporting includes only the taxonomy alignment that has been reported by the companies themselves.

• What was the share of investments made in transitional and enabling activities?

The Fund’s share of taxonomy-aligned investments during 2025 amounted to 0.16 percent in transitional activities and 3.84 percent in enabling activities.

¹ Fossil gas and/or nuclear related activities will only comply with the EU Taxonomy where they contribute to limiting climate change (“climate change mitigation”) and do not significantly harm any EU Taxonomy objective — see explanatory note in the left hand margin. The full criteria for fossil gas and nuclear energy economic activities that comply with the EU Taxonomy are laid down in Commission Delegated Regulation (EU) 2022/1214.

For 2022, the fund reported no taxonomy-aligned investments, as companies had generally not yet begun reporting the extent to which their activities were aligned with the EU Taxonomy.



What was the share of socially sustainable investments?

The Fund's share of sustainable investments contributing to a social objective was 5.07 percent during 2025.



What investments were included under "other", what was their purpose and were there any minimum environmental or social safeguards?

The Fund's "other" allocation amounted to 0.23 percent and consists of cash and cash equivalents. There are no environmental or social minimum safeguards applicable to this portion.



What actions have been taken to meet the environmental and/or social characteristics during the reference period?

Storebrand Europa was managed in accordance with its sustainability criteria throughout 2025, and companies that did not meet these requirements were excluded from the fund's investment universe. As of year-end 2025, 73 of the 394 companies included in the underlying indices had been excluded.

Our shareholder engagement activities include voting at general meetings and ongoing dialogue with portfolio companies. These engagements are conducted either directly by us or in collaboration with other investors. The objective is to strengthen corporate governance, reduce sustainability-related risks in the companies in which the fund invests, and limit potential adverse impacts on sustainability factors. This, in turn, supports positive long-term value creation.

During 2025, the fund had 149 ongoing engagement dialogues covering 98 companies. Of these, 48% related to environmental issues, 38% to social issues, and 14% to governance issues. Twenty-two engagements were conducted directly between us and the companies, while 139 were carried out in collaboration with other investors. In these collaborative engagements, Storebrand may act either in a leading or supporting role. In a leading role, we are responsible for the engagement and contact with the company. In a supporting role, we contribute capital while another investor leads the dialogue.

Of the 149 dialogues during the year, a significant proportion focused on specific ESG-related issues, including:

- 34.8% on climate change
- 32.9% on biodiversity
- 30.5% on human rights

In addition, several dialogues can be linked to the United Nations Sustainable Development Goals (SDGs), including:

- 41.5% to Goal 13 – Climate Action
- 35.4% to Goal 15 – Life on Land (ecosystems and biodiversity)
- 23.8% to Goal 16 – Peace, Justice and Strong Institutions
- 23.8% to Goal 8 – Decent Work and Economic Growth
- 23.2% to Goal 10 – Reduced Inequalities

As individual dialogues may be linked to multiple goals, the percentages may exceed 100%.

Several dialogues were also related to Principal Adverse Impact (PAI) indicators, including:

- 32 dialogues concerning violations of the UN Global Compact principles and the OECD Guidelines for Multinational Enterprises
- 29 dialogues concerning inadequate processes and mechanisms for monitoring compliance with these principles
- 16 dialogues concerning deforestation
- 24 dialogues concerning greenhouse gas emissions
- 7 dialogues concerning hazardous waste and radioactive waste

During the reporting period, the management company exercised voting rights on behalf of the fund at general meetings where the ownership stake was considered significant, in matters deemed to be in the best interests of unitholders, and in cases where proposals were assessed as being inconsistent with the management company's ownership governance policy. During 2025, voting rights were exercised at 241 general meetings, corresponding to 92.23% of the fund's assets under management.
